We celebrated another Summer League Day with Popovers in Pasadena on July 29th. Sixty-one (61) members from Leagues all around Los Angeles County came together to talk about Meeting the Challenge of Health Care.

Workshops were held for Presidents who met to talk about their common concerns with past LWV/LAC Presidents Sally Seven, Kay White and me. Redistricting Action was led by Chris Carson, who it was reported was "Very informative and the subject well-handled." The workshop on Social Policy Action with Stephanie Welch of the Los Angeles County Department of Mental Health discussed Nimbyism (Not In My Backyard) regarding new sites for County clinics and was described as "An excellent presentation." The workshop on Voter Service Action was held with Lois Ledger who spoke about preparing for cable TV broadcasting, Frances Talbott-White on Smart Voter, and Nelson Fernandez, County Registrar's Office, who gave us an opportunity for hands-on experience with new verifiable voting equipment. Those attending that workshop said, "Well done, good information about November election changes, and always new tidbits to learn."

There were six discussion tables at the luncheon related to each of the four workshops above as well as

two more; one for Working Party for Children and another for Webmasters/Smart Voter.

Spirited speakers were **Emily Gold**, Field Deputy for State Senator Sheila Kuehl, and Dr. Ellin Lieberman, President of So. Pasadena Health Care for All and Emeritus Professor of Pediatrics at the University of Southern California School of Ms. Gold spoke about the current legislation SB840, the California Universal Healthcare Insurance Act (CHIREA), that is making its way through the California She predicted passage in the legislature but opposition by the Governor. Dr. Lieberman discussed SB840 from a doctor's perspective; the current lack of health

care for many ordinary citizens and how it affects patients and doctors; the proposed bill that will provide healthcare for all and how more people could be treated for less money. Both, she and Ms. Gold answered questions from the audience. It was commented that this was a great topic and that we received good answers to questions.

Many of those that attended the meeting said that taking part in a League Day gives you the opportunity to network with League friends too seldom seen. Another League member said about what she liked best about the day, "The knowledgeable audience at each program. Impressive women!"

What's Sludge? And Anyway, Why Should We Care?— Lola Ungar

I'm glad you asked about **sludge**. Sludge is actually a part of the sustainability of our communities. Many of you knowledgeable Leaguers know that all of us in Southern California rely heavily on imported water. And, you also understand what happens to this water after we use it. It doesn't just disappear down the drain. Rather, the resulting wastewater is collected, treated, and discharged in inland and coastal wastewater treatment plants. But, what about the wastes separated from the wastewater after it's

treated? That's **sludge!** A great deal of money (billions of dollars) has been invested by cities, special districts, and the county - funded by taxes and fees – to remove wastes from sewage - but do you know how the resulting waste (**sludge**) is handled?

a. Sludge can be dried and sent to a municipal waste landfill - but – it is expensive to dry, and uses valuable space in our landfills.

Residents and businesses in the County of Los Angeles have invested substantial capital in technology to treat the sewage we generate in our daily lives. And, after undergoing treatment to b. Sludge can be treated and then reused in agriculture.

clean up that sewage so that it is safe to discharge into our streams and ocean, we are left with the same old sludge - i.e., the solids that have been separated from the treated wastewater. As you might imagine, a humungous amount of sludge is generated in Los Angeles County. And many of our wastewater treatment plant operators are treating and recycling the sludge, creating "biosolids" that are suitable for reuse in agriculture.

By now, you are probably saying, "Yuck." But, federal and state agencies have long recognized the challenge of managing sludge (biosolids), and have developed regulations and guidance to encourage proper handling, reuse, and disposal of sludge. A lot of money (billions of dollars) has been invested by cities, special districts, and the county - funded by taxes and fees – to remove wastes from sewage - but do you know how the resulting waste (sludge) is handled? In the past, sludge, in a semi-solid state has been transported to Kern County by trucks. **But, last spring, Kern County voters passed an initiative that rejects further exports of biosolids to Kern County. Now what?**

New ideas and approaches are needed to manage all the sludge generated by all of us in Los Angeles County. One such idea is to inject sludge into old petroleum reservoirs under Terminal Island. In fact, we have learned that the US Environmental Protection Agency (EPA) has made a preliminary determination to approve a permit for a project, proposed by the City of Los Angeles, that will allow injection of treated sludge (i.e. biosolids) from several coastal wastewater treatment plants in the County of Los Angeles and County of Orange. The City proposes to mix the biosolids with treated wastewater to create a slurry, which would then be injected into formations at a depth of about 5,200 feet below ground

surface in the area of Terminal Island. Following degradation of the biosolids (which is expected to generate methane), the City plans to recover the methane for use at its power plants.

What are the requirements and risks of injecting treated sludge under Terminal Island? - Permits

Has the City of Los Angeles thoroughly researched and mitigated any of the requirements and risks? And, has the City worked through the existing federal and state regulatory framework for the sustainable disposal and reuse of biosolids that may affect the region, not just the City of Los Angeles? Have any public hearings been held as required by the California Environmental Quality Act (CEQA)? The Water Quality Control Board's Waste Discharge Requirements (WDRs) must be adhered to before a discharger can discharge wastes to a water of the state (including subsurface disposal on land, which may impact groundwater). To date, the City has not obtained WDRs for this proposed project. When will the region's citizens be notified of any proposed action?

- Groundwater Risks

How will the water table beneath Terminal Island be affected? This proposal aims to discharge wastes to the waters of Southern California that includes subsurface disposal on land and may impact groundwater in the region. Will the construction of wells be able to fully contain the injected material? What about improperly plugged or abandoned wells in the area that may serve as unintended conduits for leakage?

- Seismic Risks

What are the seismic risks of leakage when the project area is in, or near, active seismic zones (the Newport-Inglewood fault, Palos Verdes fault, and their offshoots)?

Based on these major concerns, we are watching and waiting to hear what the next steps being taken by the EPA and the City of Los Angeles for the disposal of the region's sludge, its requirements, remediation and risks. Now that you care, we will continue to keep you posted on this very yucky topic.

In a federal lawsuit filed on August 15, 2006, the City of Los Angeles challenged the recently passed Kern County law that bars the city from dumping some 250,000 tons of sewage sludge annually on farm fields near Bakersfield.

SUPERIOR COURT RUNOFF CANDIDATE VIDEOS/DVDS






